2021/2022 Tuition Payment Agreement for 3-Day Threes

I, THE UNDERSIGNED, AGREE TO MAKE TUITION PAYMENTS TO The School for Little Children, according to the following schedule:

___ **Monthly:** Nine equal payments of **\$465.00** due the **1st** of each month, **May 1st – January 1st**.

or

___ **Semi-annually:** Two equal payments of **\$2,092.50** due **May 1st and January 1st**.

or

___ **Annually:** One payment of **\$4,101.30** (2% discount) if paid by check or ACH on or before **May 1st**. Credit card payments on or before May 1st do not qualify for the 2% discount, but are not charged the regular 2.2% processing fee.

If paying after May 1st, **\$4,185.00** will be due no later than June 1st or within 30 days of enrollment.

As a courtesy, statements will be e-mailed approximately 2 weeks before the tuition due date to those choosing the monthly payment plan. A late penalty of \$10.00 a month may be imposed after the 5th of the month. Payments may be made by cash, check, or ACH. Credit cards are accepted, but are subject to a 2.2% processing fee.

After December 31st	No tuition is refunded
